#### 2019 Sutton Survey Highlights

People like living in Sutton and most expect to continue to live here for quite a while into the future. The challenges of living in a small town are also the very things that many like about it. The many beautiful ridges can also be a barrier to people feeling like they are a part of the town.

While over 75% of the respondents were either satisfied or very satisfied with all town services, the cost of living here is of concern. The cost of taxes, transportation and utilities is a challenge to members of our community. Many did write comments that they felt the town is efficiently run and our fire department got top scores (99%) on satisfaction. Kudos to our fire department.

Of note is the percentage of people who anticipate that they or a family member will need elder care within the next five to ten years. Forty percent of our residents are retired. Perhaps the Selectboard could appoint a committee to look into which services will be needed, what is available through our appropriations to various programs and whether those services can meet our residents' needs cost effectively.

The two areas that generated a number of comments were ATVs/UTVs on the roads and the enforcement of zoning regulations. There has been an "ATV Committee to address the first issue. One issue concerning zoning is the inconsistent enforcement of the zoning regulations. These are topics about which many people feel very strongly on both sides. Respect and patience are called for as we work through these issues and balance individuality with living in community.

Many Sutton residents are concerned for the natural environment and changes in our climate. Many have already tried to decrease their energy consumption, compost more and use less plastic. The majority of our homes were built between 1950 and 2000, making them prime for energy audits and upgrades in efficiency. The average commute to work is 38 miles round trip and most people commuting would not car pool because they either need their vehicle for their work or they work odd and/or variable hours. This will be an issue for Sutton as we seek to meet state goals for energy consumption with respect to transportation. Many people use wood stoves but the majority do not have catalytic converters.

It is also clear that we are not meeting the communication challenge voiced by many residents. A plan of action to better communicate the events, meetings and issues in town needs to be devised so Sutton residents are better informed.

One of the highest priorities noted in the survey was the provision of high quality internet and telecommunication services in Sutton. It was felt that this is a necessary service to keep our youth in town, to grow businesses and to meet the challenges of modern day living. Other priority areas were: addressing speeding cars, developing businesses, reducing litter and developing recreational activities.
